What is the community foundation?

Established in 1994, the Community Foundation builds community assets for perpetuity. The Community Foundation is entrusted with substantial amounts of money over time from the contributions of people of all walks of life. The Community Foundation uses the income from these funds, in the form of grants, to meet the community's charitable needs now and into the future.

Most of the funds at the Community Foundation are endowed funds--permanent funds that create a sustainable flow of grant dollars forever. Through prudent investment, both the body of the endowment and the distribution available for grantmaking increase over time.

The Chester County Community Foundation has three unique features:

INSPIRE LEGACY **PHILANTHROPY**

As we work with families, individuals, businesses and nonprofits to grow legacy philanthropy, our fund advisors and donors continue to be generous. Supporters of the Community Foundation are passionate about the power of philanthropy to address community needs and make positive change. Each day, we are inspired by donors who create legacy funds, giving to the community they know and love.

During this past year:

- the Community Foundation proudly awarded \$2.3 million to the community—an increase of 65% from last year. The average grant size increased from \$3,300 to \$4,300;
- 20 new funds were created, bringing the total number of funds to 345; and
- contributions totaled \$4,463,788 from 2,575 donors.

Since our 1994 founding, \$29 million has been awarded via 6,453 grants and scholarships.

During Peter Temple's two-year tenure as Board Chair, the Community Foundation's net assets grew **48%** -- from **\$29.3** million in 2012 to **\$43.3** million in 2014. What terrific growth in philanthropy celebrated at our June Jubilee!

How do we explain such growth? We know that many people who live and work in Chester County have abundant resources, a great deal of generosity, and significant community involvement. Arts, culture, education, human services, health care, and religion are important to the fabric of our community.

We also attribute our substantial growth over the past year to the Foundation's enhanced ability to handle complex gifts; especially complex **planned** gifts. The Community Foundation has evolved institutionally into a charitable organization that provides easy, tax-effective, customized solutions for complex philanthropic estate planning situations.

Each of the Community Foundation's major gifts received in the past year has been related to planned giving and estate planning. In most cases, professional advisors (estate planning attorneys, accountants, financial planners, and investment managers) sought charitable options on behalf of their clients. The Community Foundation provides solutions they need.

We have great hopes for the future. With your help, we connect people who care with causes that matter, so their legacy makes a difference. FOR GOOD. FOREVER.

The strength of the Chester County Community Foundation is in its power to change peoples' lives. Each year, hundreds of organizations—and thousands of people—are touched through the generosity of our donors.

Our donors establish grantmaking funds at the Community Foundation. The majority of grant decisions are made by the families and individuals whose funds the Community Foundation holds in trust. The Community Foundation also grants a modest amount from its Fund for Chester County, based on decisions made by a volunteer Grants Committee. The average grant size increased to \$4,300.

During FY2014, \$2,295,233 in grants and scholarships was awarded to address needs in our community.



The Honorable Dr. Clifford E. DeBaptiste

The Community Foundation spotlights the Honorable Dr. Clifford E. DeBaptiste as he celebrates two milestones this year:

- He was born on May 18, 1924.
- He opened the DeBaptiste Funeral Home on September 12, 1954.

90 years of age and 60 years of business: hence, the 90/60 Special Award.

The young Clifford first visited West Chester in the 1940s.

This began a lifetime love affair with the town, and he vowed to return and open up his own business. In 1954, after serving in the U.S. Army, graduating from mortuary school, and marrying Inez Manning, they opened the DeBaptiste Funeral Home in the borough. The business prospered. They opened a larger facility during the Great Blizzard of January 1965 at 25 South Worthington Street, where it remains to this day.

"Uplifting life through service" is Dr. DeBaptiste's credo.

He is widely known for his business acumen, civic leadership, religious guidance and community philanthropy. Four years after his beloved wife Inez passed away, Dr. DeBaptiste took office as West Chester's first African American Mayor. He served two incredibly successful terms from 1994-2002.

Dr. DeBaptiste's good deeds go far beyond West Chester.

He has been honored by the NAACP for his business leadership. In 2009 Dr. DeBaptiste was recognized by the National Purple Heart Association for his service in the U.S. Army during the 1940s and in the Korean War. In 2014 Dr. DeBaptiste

was coronated a Sovereign Grand

Inspector General, which is the Thirty-Third and last degree in Ancient and Accepted Scottish Rite of Freemasonry.

A member of numerous local, county, state and national funeral director associations, Dr. DeBaptiste was appointed by the governor to the Pennsylvania State Board of Funeral Directors which he chaired for 13 years.

Education is the focus of Dr. DeBaptiste's philanthropic

commitments. A long-time supporter of West Chester University, he served as a member of the Council of Trustees from 1968 to 1972 and as a board member of the West Chester University Fund. In 1991, he was awarded the President's Medallion for Service, and in 1999, he received an honorary doctorate of public service.

In 2014, Dr. DeBaptiste made a lead donation to kick off a successful fundraising campaign spearheaded by the University's Frederick Douglass Institute. The Institute commemorates the former slave, distinguished orator, author, abolitionist, and statesman who delivered his last public lecture on West Chester's campus in 1895.

In addition, Dr. DeBaptiste has granted scholarships to countless students through his charitable funds at the Community Foundation and from his personal resources. **Uplifting lives through service...for now and forever.**

The Vanguard Crew

The Vanguard Crew's willingness to dedicate time, talent and treasure through a wide variety of activities is truly inspiring.

Headquartered in Valley Forge, Vanguard is one of the world's largest investment management companies. Vanguard employees, called "crew members" have created a culture of social engagement and made a valuable and long lasting connection with their surrounding communities.

Possibly one of the Vanguard Crew's most visible long lasting connection with their surrounding demonstrations of giving back and making a long lasting communities. impact is the Vanguard Community Garden. To bring this Vanguard's service efforts demonstrate the philosophy of garden to life, crew member volunteers teamed up with community engagement and philanthropy at work. The Triskeles Foundation as part of its Food For All project. Vanguard Crew has an extensive connection to United Way, Together they installed 21 raised garden beds, a water particularly through its annual fundraising campaign. When asked to give his own explanation of the 'American Dream,' Miguel describes it as being willing and able to give back to the community.

With passion and drive, Miguel has been instrumental in bridging the gap between the Angelo and Latino

communities. He does this via his professional career, his acts of service, and his charitable giving.

Miguel serves the community by not only donating time and capital, but also talent. Both professionally and voluntarily, Miguel provides bilingual and bicultural services. He educates Latinos in finance areas, including how to shop for the best loan and interest rates. He helps individuals and business owners avoid scams and deal with immigration issues. Through SCORE, Miguel regularly provides workshops on how to succeed as a Latino business owner. With his help, Latino business owners have been empowered to strengthen their businesses, and to give back to the community as well.

Since 2010, Miguel has served on the Board of Directors of La Comunidad Hispana. In 2013, he joined the Board of Directors of the Southern Chester County Chamber of Commerce.

As a volunteer with The Garage Community & Youth Center, Miguel's advice and counsel helps the organization better serve the Latino community, which makes up over 55% of The Garage's clientele. To help with constituent building and fundraising, Miguel brought a dozen new donors to The Garage's West Grove and Kennett Square banquets. Miguel helped raise awareness and participation in The Garage's Holiday Auction; revenue increased by 150% from the previous year. It is inspiring to note that when Miguel arrived in the U.S., he didn't speak much English. He

arrived with his B.A. from University of Piura in Peru and a tremendous amount of energy. Determined to embrace all that America has to offer, he immediately started bagging groceries at a supermarket and worked as a sales clerk at CVS. Miguel also taught Spanish part-time at Bishop Shanahan High School, Cabrini College, Immaculata College, Villanova University and West Chester University. As he learned the English language, he earned a Master's degree in international law from Temple University.

Miguel went on to work at MacElree Harvey, and then at First National Bank of Chester County. He is now with Elite Group serving as Vice President of Avanti Seguros, and the founding owner of Hispanic Approach, LLC. With his law, banking, and insurance experience, Miguel is an extremely well-rounded bilingual, bicultural sales and business development executive.

Personally and professionally, Miguel is breaking down cultural barriers, forging relationships to support initiatives that will have a lasting impact on generations to come.

"I want to give back to the Hispanic community," Miguel says. "Hispanics are very hard-working people. They are loyal. I live what they live. I eat what they eat. I dance what they dance. 
JORDAN AWARD HONOREES

Richard A. Kunsch, President & CEO, **Phoenixville Federal Bank & Trust**

Dick Kunsch has a clear modus operandi: "I want to leave the world better than I found it. I like to get the ball rolling, set examples, and have impact."

Why? Because Dick Kunsch always remembers his roots.

Dick's roots are in hard work. Dick remembers his father as "a soft-spoken, kind, gentle man who worked hard and long--seven days a week at BFGoodrich." Mom was the tough one. "Though kind, she was the disciplinarian. She worked as a bookkeeper at the local hardware store, as a salesperson at the local bakery, and in medical records at the Valley Forge Army Hospital. Always working so hard, inside and outside our home. That work ethic made an impression on me."

Dick's roots are also religious. "My parents were both very religious...Sunday school teachers and choir members most of their lives. As a result, our family activities were centered at church."


Dick's roots are also community. "Growing up in Phoenixville, I remember a lot of front porches. People watched over the children of the community. And we had all kinds of people. Phoenixville has always been a melting pot. Iron and steel brought ethnic workers--an extremely diverse group with an incredibly strong work ethic. We all

had to work together, play together, worship together, and respect each other in order to succeed."

But it wasn't simple for Dick. "I didn't know what I wanted to do when I graduated from high school. I went to college for a couple of years, and stopped. Then I worked at Bell Telephone of Pottstown. It was hard work; we were outdoors guite a lot in harsh conditions."

On Fridays, Dick would go to the local bank to cash his paycheck. "One day I decided that it was time to make a change. I realized that I wanted to be that bank teller I saw every Friday. So I went to work at Industrial Valley Bank. Six months later I was offered a position at Phoenixville Federal Savings & Loan Association. What I found was a home and not a job, and I am still there today. I started at the bottom and worked my way up through the banking business. The bank sent me to Philadelphia to banking school. I learned every job, every step of the way. I believe when you do it that way, you're more sympathetic to the needs of all the employees."

As Dick's banking career developed over time, his beloved Phoenixville declined. The 1960s, '70s and '80s took a real toll on Phoenixville. Steel and iron, the Valley Forge Army Hospital and other local manufacturing plants moved out. Phoenixville was declared "dead."



Yet today, as the mythical bird in its name, Phoenixville has University of Pennsylvania Health System, and then with risen from its ashes. What stimulated the rebirth of Phoenixville? A combination of the right people, in the right place, working together at the right time, joining forces and resources towards a common goal. Though he won't say it directly, those involved in Phoenixville's rebirth agree: Dick Kunsch and Phoenixville Federal Bank & Trust have been at the nexus of Phoenixville magnificently rising from its own ashes.





Lancaster Ave. St. Joseph, Downingtown Although he appears to be passive, John stores a supply of energy for unexpected happenings.

Much has happened to John and Pat Celii in the five decades since their 1961 graduation. True to Bishop Shanahan's school motto, together they "seek the things that are found above" in a variety of facets. "Life is about risk---strategic, calculated risk," intones John Celii. Adds Pat, "It's also about family...having an incredibly strong support system so that you can take chances, and share the rewards if they come your way." "Fortunately, the rewards came our way," explains John, "because we're lucky. Damn lucky. However, we made many sacrifices and worked hard to make that luck happen."

John and Pat finish each other's sentences. They seem to read each other's mind. It is clear that these high school sweethearts are still very much in love after five decades. They live in a gorgeous 19th century gentleman's farmhouse restored by the best architects and builders around. Lovingly decorated by Pat, her flair for artistic design shows in every nook. And their philanthropy is inspiring. "Philanthropy began with restoring our home," jokes John. "And it readily extended to the community around us," explains Pat.

- He was on the baseball team...She was his cheerleader.
- He was from Downingtown...She was from Kennett.
- He was from a small family...She had relatives too numerous to count.
- He was a "class clown" whose mother begged Reverend Kehoe to accept him at Bishop Shanahan High School and to "straighten him out"...She was a diligent student and volunteer church organist, who later discovered that the Shanahan nuns yearned to recruit her to the Sisterhood.
- In his senior year book, his friend Buddy noted, "If you ever succeed in life it will be a surprise to me."... In hers, it said, "Art may claim this cordial senior."
- Opposites attract...It has been an incredible journey.

Of course it wasn't always easy. After the high school sweethearts married in 1962, they lived in the tiniest apartment in Downingtown. John toiled at night school earning his BS in Accounting and Finance at St. Joseph's University while working full time. John left home by 7 a.m. and returned after 11:30 p.m., while Pat raised their two beautiful daughters, Jacqui and Stephanie. "I often wonder how we made it work," remarks John. "Family," answers Pat knowingly, "The kindness of grandmom and our parents. And lots of patience...a strong sense of deep commitment... and dreams...and taking chances...and hard work."

"Yes...family....Thank God for my mother in-law," laughs John. "She paved the way to get me a first interview which turned into an extremely successful 20 year career." John first worked in Avondale at F&M Scientific, just as Hewlett-Packard Co. acquired it from Frank Martinez, Aaron Martin and Gene Bennett. "It was a terrific experience...being on the ground floor of a strategic move like that." Soon after, Hewlett-Packard recognized John's natural-born talent, work ethic, and hands on experience. "Moving to HP's corporate headquarters in Palo Alto, California at the dawn of the computer industry was huge!" exclaims John. John traveled extensively for business, coast to coast many times over, delving into both Finance and Marketing with Hewlett-Packard. John went on to become VP of Finance and CFO at 3Com Corporation, then headed up Mergers & Acquisitions at Convergent Technologies, and served as President of Convergent Dealership Systems. "I rarely saw the family. I was on the road so much. I knew that Pat was raising our daughters almost single-handedly. But I loved the thrill and the pace and being in on the ground floor while the computer industry was developing in Silicon Valley in the 1980s, and Pat knew that."

"I could see how much he thrived... there was no stopping him. We missed him terribly, but he was so, so good at what he was doing. We had to help him live his career dreams," Pat adds wistfully. Sometimes the family lived on the East Coast. Sometimes on the West Coast. Sometimes on both coasts, simultaneously. "We did what was right for the family, for each of us, and the kids. They were great years; and at the same time, they were very trying years."

Finally they had enough. John retired in 1990 at age 48 and "relaxed a spell." "If you can call it 'relaxing," jokes Pat. John spent the next three years in Chester County with his family. His days were filled with fishing, collecting cars, and playing high stakes poker. John created his Standardbred Racing enterprise--the one that fostered their pride and joy, Badlands Hanover. "Badlands was a world champion Standardbred racehorse, and is now a very successful sire. It's a thrill to own such a gorgeous, strong, powerful animal."



Out of the blue in 1993, the corporate world came calling. "It was a startling offer, and we said 'no' right away. But the recruiter circled back a few more times and wouldn't quit. So we set forth a ridiculously steep set of conditions to chase them away and to our surprise, they were met." After much heart-felt conversation, John re-entered corporate life as CFO of a start-up company, Grand Junction Networks. The high-stakes, calculated gamble paid off. Grandly. Grand Junction was eventually acquired by Cisco Systems, and John headed up Cisco's East Coast merger and acquisition team.

In 1998, John retired for the second and final time. He and Pat settled back in Chester County, at long last, together full-time.

In 1999, Pat began a massive restoration of their newly purchased 1839 historic Chadds Ford home, "Keepsake." She strove to protect the home's historic and architectural qualities, yet fill it with modern amenities. The project involved restoration of the original 1836 house, reconstruction of the 1850s smokehouse, construction of a major addition, a linking building and two new outbuildings, and extensive site landscaping.



No detail, inside nor out, escaped Pat's loving attention. Architect John Milner explains, "Pat was instrumental in the interior design, including salvaging and acquiring antique architectural materials, furnishings, fabrics, and decorative arts. A true labor of love, Pat's fine interior decoration complements the period architecture and stays true to its Brandywine roots."

Knowing that a project is only as good as its general contractor, the Celii's give exceptionally high marks to Spencer Abbott Builders. John notes proudly, "They did a superb job, exercising great skill in managing the construction process and all aspects of the execution." Collaboration out-of-doors was also critical to the home's picture-perfect presentation. Jonathan Alderson Landscape Architects reconfigured and redesigned the entire site to make the three separate parcels of house work together, with terraces off all the main rooms, new gardens, screening from the road, and a realigned driveway. Every tree, every shrub, every flower, every pathway, every statue was lovingly and carefully selected by Pat.

As their home was being restored, John shared his extensive knowledge and expertise by serving on several high-tech companies' Boards. And John remembered where he came from, first serving on Bishop Shanahan High School's Advisory Board, and later joining the Chester County Community Foundation Board of Directors.

While serving on Bishop Shanahan's Advisory Board, John and Pat began to realize that the Celii family could use their hard-earned wealth to strategically help others. The Celii family created a scholarship fund to benefit Shanahan students. Also, they became leadership donors to Bishop Shanahan's capital campaign, with a special gift to build and decorate the Celii Chapel. "We needed to honor my mother and Reverend Kehoe," explains John, "because our lives would have taken far worse turns if they hadn't pushed me."



Given some time to ponder what to accomplish next, John and Pat once again realized the import of Shanahan's motto to "seek the things that are found **above.**" For years, those near and dear to them had fought battles to cure chronic illnesses. While some won, others lost. The Celii family decided to focus their abundant talents, energy and resources to help others who face health issues.

They thought about starting their own family foundation. However after discussing ideas with their CPA and trust attorney, they found an easier method to achieve their philanthropic goals. John explains, "We decided to join an existing organization that was already up and running, and that had expertise in grant making activities. We reviewed what the Community Foundation was trying to accomplish, and we readily concluded that it could facilitate our philanthropic objectives."

"We have maintained a very good relationship with the Community Foundation since we created our donor advised fund in 1999," John says. "They have made many good suggestions relative to where we could make a difference in the community. They have allowed us truly to be 'donor advisors' and make our own decisions regarding grant making. Once we make a decision, we inform the Foundation staff, and they make it happen! Pat and I are very happy that we decided to join forces with the Community Foundation to achieve our gifting strategies."

The Celii family makes grant decisions based on logical analysis combined with heartfelt passion. One of their first major health grants focused on thyroid cancer research. All too familiar with thyroid issues, the Celii family knew that 12 million Americans have thyroid nodules that require medical evaluation; that 33,000 Americans are annually diagnosed with thyroid cancer, which afflicts women three times more than men; and that SE PA and New Jersey have among the highest rates for thyroid cancer in the U.S. The CCCF Celii Medical Research Fund provided critical funding for the Penn Thyroid Center, which in conjunction with Abramson Cancer Center of the University of Pennsylvania provides a full range of diagnostic and treatment options for thyroid cancer, including surgery and external beam radiation, and long-term

follow-up. Integrated with Penn's world-class Division of Endocrinology, Diabetes, and Metabolism, and the Abramson Cancer Center, the Penn Thyroid Center coordinates translational and patient-oriented research, providing innovative partnership with basic science discovery.

The Women's Specialty Care Center at Chester County Hospital is another shining example of the type of philanthropic projects that the Celii family finds rewarding. After touring and learning about the hospital's many worthy projects, the family realized how much women's health resonated with each of them, in a big way. They decided to make a six-figure challenge gift to incentivize other leadership donors.



In 2009, the Specialty Care Center opened its doors to women.

Pat quietly explains, "The Center is especially designed to create a calm, coordinated, patient-centered environment. In too many places, women are left in the dark about the details of their health care, and the system is fractured and communicates poorly. So much needless running around and worry, at a time when a woman needs to focus her energies." The innovative, state of the art Center expertly addresses women's needs related to breast care, gynecologic/ oncology, urogynecology and genetics counseling.

Additionally, The Celii family has funded Chester County Hospital's DaVinci Robotic Surgery technology, and the hospital's Emergency Room renovations. We've been in E.R.s far too often," Pat explains.

As John and Pat look to the future, they are clear that family philanthropy is a cornerstone. "We remember when we didn't have two nickels to rub together," says John ruefully, "and we know what it's like to feel helpless even when you have love and resources around you."

"Our daughters and our granddaughter have started to pave their own way in the charitable world, and we are proud of them." Pat explains, "They care about different things than we do, and that's O.K. Actually, it's great. They are their own women, and they are generous, caring, daring and strong. We look forward to the journey as they become even more involved with the needs and aspirations of the world."

John and Pat Celii's life journey is something of a "rags to riches story." The Celii family has many options regarding what to achieve with their wealth, and how to execute their objectives. As they continue to "seek the things that are found above," the Celii family continues to make a positive impact in their community, generously giving their hard earned wealth through strategic, empassioned grantmaking; and volunteering their time to make the world better.

LEGACY FUNDS: What Legacy Will You Leave?



Legacy philanthropy is much more than sending a check. It ensures your continuing support for causes you care about, in perpetuity. It gives you the opportunity to carry on a family giving legacy. Combined with careful estate planning, it ensures that your personal resources are used to accomplish your financial and charitable goals.

Gifts to the Community Foundation can be made at any time to provide grants for current community needs and for perpetuity. By establishing a fund with the Community Foundation, you receive:

- Permanence: The Community Foundation's trusteeship ensures that your contribution will continually meet needs relevant to your interests.
- Commemoration: Your name or the name of a loved one can live on through your fund. If you prefer, you may choose a name that reflects your fund's charitable purpose.
- **Stewardship:** The Foundation's Board of Directors, with guidance from its Investment Committee, staff, and outside investment counsel, closely monitors the performance of professional investment managers. The Foundation makes a full accounting to the community through its annual report, audit, and IRS Form 990.
- Grantmaking Expertise: The Community Foundation expertly assists in identifying charitable organizations and programs that address your particular interests and core values.

The Community Foundation primarily holds endowed funds in trust. We also manage some provisional funds.

- Endowed Funds are allowed up to a 5% grant payout for perpetuity, to assure that grant funds are always available to help nonprofits.
- Quasi-Endowed Funds are allowed up to a 20% grant payout, which means the principal will be diminished over time.
- Provisional Funds can be paid out in full at any time.

Grants awards are made to bona fide nonprofit causes throughout the United States.

TYPES OF FUNDS CCCF Funds

- Fund for Chester County gifts enable the Grants Committee to award strategic grants to Chester County nonprofits.
- Lincoln Building Fund gifts support the renovation and repair of the Foundation's historic 1833 headquarters.
- Operating Endowment gifts allow the Foundation to focus on its core mission, growing legacy philanthropy throughout the region.

Field of Interest Funds

Donors who seek to impact a targeted issue area (arts, education, environment, health, human service, religion) or specific geographic region establish Field of Interest Funds. By naming an interest area rather than a specific organization, flexibility exists to meet ever-evolving community needs.

Donor Advised Funds

An alternative to a private foundation, Donor Advised Funds are popular with donors who wish to establish a Foundation without incurring administrative operating and compliance filing burdens, while capitalizing on the Community Foundation's philanthropy expertise and nonprofit field research. Donor Advised Funds enable individuals, families, community groups, and businesses to focus their philanthropy and make grants that impact the causes they care about most.

Organizational Endowment and Nonprofit-Designated Funds

Designated Funds are created by nonprofit organizations and individual donors who care about the long-term success of particular nonprofit charities. This lets donors support specific charitable organizations for perpetuity, while the Community Foundation manages investments professionally and monitors for accountability.

Scholarship Funds

Establishing a Scholarship Fund allows the donor to support students pursuing education beyond high school. A donor may name the scholarship's selection committee and the guidelines for candidate selection. Most scholarships at the Community Foundation benefit disadvantaged, promising students from a particular high school, or those who pursue a particular field of study.

Memorial Funds

Donors can quickly and cost-effectively create commemorative funds honoring people they hold dear.

LIFETIME GIFTS

Your charitable interests can be supported during your lifetime—and in perpetuity—through your gift. You will have the satisfaction of seeing the impact of your generosity as you carry out your charitable objectives.



INVESTMENT MANAGEMENT

Portfolio Objectives

The Foundation is committed to prudent investment management strategies and fiscal policies that it believes will lead to the long-term growth of endowment fund principal and meet the Foundation's distribution policy objectives. The Foundation seeks to preserve and enhance the value of the portfolio's assets by providing long-term growth greater than the rate of inflation and fee costs, while recognizing that prudent risks must be taken.

The Foundation's investment goals are:

- 1. to achieve a return in excess of the target return
- 2. to minimize portfolio drawdown risk, to the extent possible, in seeking to achieve the Foundation's long-term growth objectives.


Endowed Funds Long Term Target Return: The Foundation desires a long term target return that provides portfolio growth, exceeds inflation, covers investment fee expenses, covers the Foundation's administrative fee, and covers the annual grant payout (of up to 5% of the previous fiscal year end balance). Based on the fluctuating actual spend, the minimum required long term target return will be defined as the trailing 5 year actual spend rate + Current CPI + administration fees.

Quasi-Endowed Funds Long Term Target Return: The Foundation desires a long term target return that provides portfolio growth, covers investment fee expenses, covers the Foundation's administrative fee, and covers the liquidity necessary for a potential annual grant payout (of up to 20% of the previous fiscal year end balance).



The Investment Policy is formulated on a long-term, broadly diversified strategic asset allocation plan with asset class targets and operating ranges.

As the Foundation's CIO, Hirtle Callaghan's full time focus is to deliver strategic and proactive asset class guidance and total investment program implementation of the portfolio's assets including the identification, selection, and termination of investment managers. Hirtle Callaghan is also responsible for retaining and directing the activities of the independent custodian, and all other vendors involved in providing data, analysis and other services used to manage the portfolio. Hirtle Callaghan provides quarterly statements and performance reports, net of all fees, with comparisons to relevant benchmarks.

Medallion Investment Partners – Separately Managed Invested Assets

The Community Foundation's Medallion Investment program gives you the opportunity to establish a donor advised fund at the Community Foundation, while having a qualified advisor you choose continue to manage the asset and receive investment management fees. It all adds up to a winning formula:

- donors supply the charitable passion
- wealth managers and investment advisors supply the investment expertise
- the Community Foundation supplies the charitable legacy vehicle

All get credit for the perfect charitable solution.

- Medallion status is awarded to investment advisors/firms which pass an annual due diligence review undertaken by the Community Foundation's Investment Committee. Medallion funds are separately managed, non-aggregated funds, which receive their own investment return. The Community Foundation may charge a modest additional annual fee to the charitable fund for this service.
- The minimum amount to start a donor advised fund in the Medallion program is \$250,000 with the intent to grow to at least \$1 million. The minimum for non-medallion investment partner program funds is \$25,000.




