## Kennett Symphony – UPDATE

## **EDI Grant Proposal to the CCCF**

- The League of American Orchestras confirmed the Kennett Symphony's grant award.
  - We are honored to be one of 25 orchestras across the nation to receive this grant. Page 3 of the release includes the full list of the other orchestras that have received this grant funding. We are in the company of venerable orchestras like the Los Angeles Philharmonic, New York Philharmonic, Pittsburgh Symphony and St. Louis Symphony. Those orchestras range in budget from \$50million to \$190million. With our budget of \$350,000, we're the smallest budget, fully professional orchestra on the list.
  - We are looking forward to learning from and sharing with the other orchestras on the list via the four convening sessions over the course of our one-year projects. Having access to the EDI learnings and projects of the 24 fellow grantee orchestras will further grow our understanding and training.
- We have hired EDI consultant Daria Torres of the Walls Torres Group. Ms. Torres will help us create a short and long-term plan for EDI for the Kennett Symphony. Information on Ms. Torres is below. The Catalyst Grant provides funds for 80% of the cost of an EDI consultant (we need to raise the remaining 20%, hence our application to CCCF).

- We are hopeful that our current grant proposal and request for \$4,000 via the CCCF will be successful. The \$16,000 grant from the League represents 80% of the total \$20,000 consultant fee for this project. We are required by the grant guidelines to raise the remaining 20% of the consultant's fee, which is \$4,000.
