## GRANT PROPOSAL GUIDELINES

- The Chester County Community Foundation connects people who care with the causes that matter, so their philanthropy makes a difference now & forever.
- We are a collection of Field of Interest & Donor Advised Funds with \$5M + granted annually to nonprofits in Chester County & beyond.
- 99% of our grants are made by our generous Fund Advisors, who make grant decisions all year.

### Proposals submitted by nonprofits are considered for 2 types of grants:

## Field of Interest & Donor Advised Funds (No Deadline)

- Grants focus on Chester County causes & issues, but are not limited to Chester County.
- Charitable nonprofits working in all fields of interest are considered for grant awards. (I.e. arts, culture, & humanities; education; community improvement; environment; religion; health; & human services)
- General operating grants are encouraged.
   Nonprofits should be specific about their mission, goals, & measurable outcomes.
- ♦ Proposals can be submitted <u>anytime all year</u>.
- Grant decisions are made intermittently all year, as Fund Advisors desire.
- ♦ Grant awards typically range from \$500-\$7,500.

## Fund for Chester County Capacity Building Grants (Due 9/11)

- ♦ For eligibility in this grant program, nonprofits must be located in & serve Chester County.
- Nonprofits **budgets** must be **\$500,000 or less.**
- The goal of capacity building grants is to strengthen the effectiveness of NPO's serving the region, see page 4 for more details on the areas including:
  - Mission, Vision & Strategy
  - Governance & Leadership
  - Partnerships & Collaborations
  - Operations & Technology
  - Fundraising, Development & Marketing
- ♦ Proposals submitted between <u>July 1 Sept. 11</u> are eligible for consideration.
- ♦ Grant awards typically range from \$500-\$5,000, with monies distributed by February.

- Proposals are considered "complete" when CCCF has confirmed receipt of the Grant Proposal

- Per IRS Regulations, applicants <u>must be</u> charitable, tax exempt organizations with 501(c)(3) certification & cannot be individuals.

## **Proposal Summary:**

Friends Association respectfully requests a grant of \$5,000 to assist us in completing a new strategic planning process. After 3 years of significant growth and development in our programs our goal is to lay the groundwork for continued, sustainable growth in our capacity to prevent and end homelessness for families with children living in Chester County.

## II. CHESTER COUNTY COMMUNITY FOUNDATION GRANT PROPOSAL NARRATIVE

#### 1. Nonprofit's history, goals, key achievements & distinctiveness

For over 200 years, Friends Association has been dedicated to ensuring the safety and wellbeing of children. Over the years we have refined our service model as our understanding of the needs of vulnerable children has evolved and we currently focus on housing stability, offering a continuum of care that meets families at each possible point of entry.

Taking a two-generation approach, we coordinate high-quality early learning access (Head Start, Early Head Start) for all children under the age of five. As so many of the families we serve are struggling with issues related to trauma, we work closely with behavioral health providers to incorporate these services into our emergency housing model of care.

Responding to the extraordinary housing pressures created by the COVID 19 pandemic, Friends Association worked with Chester County's Department of Community Development to create our Eviction Prevention Case Resolution Program and stewarded over \$4 million in emergency rental assistance funding awarded to the county through an American Rescue Plan Act (ARPA) grant. Our EPCR Program has been cited by the Housing Alliance of Pennsylvania for its effectiveness in preventing evictions in the district court jurisdictions we currently serve. We offer the only non-congregate family shelter in the county. Families are housed in private apartments, which allows families of all compositions to stay together and minimizes the trauma of temporary housing for both parents and children.

Friends Association believes that housing is a basic human right and that without the safety and security of a home, children cannot flourish. We aspire to build a community rooted in justice, built on equity, and grounded in the knowledge that we are all deserving of a home. To that end, we have built relationships in the business community and with local, state, and federal officials, advocating for long-term stainable housing solutions for all families in Chester County.

#### 2. Funding request

#### Description of key initiatives

Our Eviction Prevention and Case Resolution (EPCR) Program provides mediation with landlords and legal representation during eviction proceedings combined with tenant counseling with the goal of preventing episodes of homelessness while our Housing Recovery and Stabilization Program offers short-term emergency housing combined with long-term case management and life skills training to help families experiencing homelessness return to permanent, sustainable housing. In fiscal 2023-24 we provided services to 1,410 individuals in 498 households. 47% were children under age 18.

#### Strategic planning project overview

In 2022, with the completion of Friends Association's 2018 to 2021 strategic plan, the board and staff initiated a new strategic planning process. Before the project was completed, Jennifer Lopez, Friends Association's CEO, notified the board of her decision to retire and planning was suspended. In February 2024, Joyce Chester joined the organization as its new CEO. In the interim, Friends Association had undergone significant change and growth in its programs and scope of services and a decision was made to begin a new strategic planning process rather than moving forward to complete the previous plan. We have selected Compass Pro Bono and are hoping to begin the planning process in October.

#### Measuring impact

Our immediate goals are to create a refreshed mission statement that is both inspirational and clear in articulating the overarching mission of the organization, to create a meaningful DEI statement and policies, and to develop a detailed work plan that will serve as a blueprint for the development and delivery of programs and for sustainable growth over the coming three years. The priorities set forth in the work plan will be driven by the language in the mission statement.

Longer-range impact will be measured by evaluating key performance indicators including community impact – number of families served as well as short and long-term housing stabilization metrics – and sustained fundraising growth.

#### Activities, timeline, and costs

As mentioned above, Friends Association has selected Compass Pro Bono as the consulting firm for our planning process. A copy of their proposal is attached. While Compass offers some pro bono services, their strategic planning services are offered as a paid consulting service consistent with other nonprofit consulting firms. Compass has over 20 years of strategy consulting experience working with local nonprofits in communities in and around Washington, DC, Philadelphia, Chicago, and the Twin Cities. They have served 2,700 nonprofits, completed 1,430 consulting projects, and made 8,170 matches. Compass has outlined a 4 phase process as follows:

- Phase 1: Confirm strategic questions, deliverables, and work plan
- Phase 2: Assess the current state conduct focus groups, interviews, etc to solicit feedback regarding strengths, challenges, and opportunities
- Phase 3: Formulate strategic priorities based upon board, staff, and community feedback, develop overall priorities for the coming 3 years
- Phase 4: Develop the strategic framework and implementation plan build specific goals, objectives, and an action plan based upon the priorities created in Phase 3.

We anticipate early planning activities to begin in October with a goal of completing the process within 6 months.

The main cost for the project will be Compass's \$21,500 consulting fee. Incidental costs including office supplies and materials, meal or refreshment catering for board/staff meetings and focus groups are also included in the attached budget.
