MidAtlantic Horse Rescue Inc. purchases thoroughbred ex-racehorses from auctions and feed lots and transitions horses directly off the track. After quarantine and careful evaluation, they are adopted into loving homes as sport horses and pets. We focus on promoting the thoroughbred for a variety of careers after racing, highlighting their versatility, athleticism, and temperament. Thoroughbreds are suitable for a wide range of rider abilities and goals, whether it is riding around the pasture bareback or competing at the highest levels.

--- 2. Briefly outline 3-5 goals for the requested funds and how these goals support your mission. ---

We offer a series of thoroughbred only clinics at the farm throughout the year. These clinics are free for our graduates or reduced cost for other thoroughbreds. Goals: Offer training for all thoroughbreds who wish to participate, regardless of level of horse or rider; Highlight the many qualities of thoroughbreds after racing, with a focus on horses who have come through our program; Network with thoroughbred owners in the region and expose newcomers to thoroughbreds as sport and pleasure horses.

Series of 3-5 thoroughbred only clinics at the farm throughout the year. Each clinic will feature a well known established trainer who is focused on thoroughbreds, and offer training for all levels of riders and horses, from inexperienced amateurs to junior riders to older adults and to current professionals. These clinics create opportunities for homes for thoroughbreds post racing and build solid foundations for current thoroughbred owners. They also trouble shoot issues riders may be having with their horses.

Series of 3-5 clinics May-April. Each clinic generally attracts 20-30 rider in each with a total of 80-120 riders and their horses helped.

Clinic fees vary by clinician- in 2024 each clinician charged from \$60-\$75 per horse and rider.

Sample budget:

Clinic 1 20 riders @ \$75- per rider = \$1500 Clinic 2 20 riders @ \$75- per rider = \$1500 Clinic 3 25 riders @ \$55 per rider = \$1375 Clinic 4 25 riders @ \$75 per rider = \$1875

As we schedule clinics and get fees and participants we can adjust accordingly

Participants riding thoroughbreds not adopted from MAHR pay a \$40- fee per rider per clinic

TERF clinics held annually at MAHR- they are very popular and attract thoroughbred enthusiasts and riders, spotlighting the many abilities of these horses post racing. We also hold open houses and attend regional and national vents as vendors, panelists, and competitors. We also host groups at the farm as well as from local schools, civic groups, and colleges.
