<b>Proposal Summary:</b>		

Restore Counseling Center respectfully requests \$7,500 in general operating funds to support the mission of providing faith-based individual counseling and group therapy sessions to adults and children throughout Chester County. Highly skilled therapists provide counseling and lead group therapy sessions to address issues and challenges related to trauma, anxiety & depression, postpartum depression, marriage and infidelity issues, sexual addictions, and crises. Mental health services are provided to meet the needs of children 4-17 years of age, and adults 18 to over 65 years of age. The highest quality of mental health services are provided to clients, regardless of their ability to pay, to restore hope, peace, and joy to their lives.

1. Restore Counseling Center's History, Goals, Key Achievements, and Distinctiveness History

While Todd E Henley, Founder and Executive Director, was working on his Master's in Counseling, he was hired at Day Seven Ministries as a therapist. Many times, he would come home and say things to his wife and children like, "I'm feeling led to lead a mental health seminar in Lancaster on working through anxiety or depression."

One time, when he came home with one of his ideas, his wife stopped him and said, "You are always talking about what you want to do for Day Seven. Have you thought about opening your own counseling practice?" Todd paused for about three seconds and responded, "No, I've never thought about it." With this in mind, his dear wife said, "Well, think about it and pray about it."

That night, Todd had trouble sleeping as he thought about a counseling center in his community. The adrenaline and excitement kept him up throughout the night. Within three weeks, he had the vision for his community—the vision to bring healing and hope to traumatized people. His wife asked him if he had thought of a name, and he said, "Restoration Counseling Center." Amazingly, she said, "Oh, I thought of Restore Counseling Center." Todd joyfully responded, "Oh, I like your name better, so let's go with Restore Counseling Center.

Todd's church has been a tremendous support, giving Restore Counseling Center the office space to counsel free of charge. After much prayer and many legal documents, Todd and his wife agreed he would stop working at Day Seven and step out in faith. Restore Counseling Center opened on May 1, 2021, and has been serving and growing ever since!

### Goals

As Restore Counseling Center looks ahead, we have several goals in mind:

- Continuing counseling services to ensure that every client seeking help can receive appropriate support.
  - Renovating a local farmhouse for our office space providing a private and peaceful setting for counseling sessions and the expansion of group therapy services.
  - Expanding Play, Nature, and Equine-assisted Therapy groups for children ages 4-17.
  - Fostering partnerships with local churches and faith-based organizations, enabling us to extend our outreach and support to even more individuals in our community.
  - Providing ongoing training for our counselors, so we can continue to provide the highest quality of care based on the latest insights and techniques in mental health.
  - Reviewing and adapting our services in response to our clients' needs and the evolving trends in mental health, ensuring we are always meeting their unique circumstances.

# **Key Achievements**

Over the past year, Restore Counseling Center has:

- Provided successful counseling and healing through art and play therapy for children ages 4 through 12 who have been abused and for parents of abused children.
- Created a collaborative team of therapists who have a strong desire to help clients heal from trauma.

#### **Distinctiveness**

The distinctiveness of Restore Counseling Center is that we are faith-based and trauma-informed, and we work with clients regardless of their ability to pay for services. Restore Counseling Center meets clients' needs by providing a number of services, including individual counseling, group therapy, and expanding services to meet our youngest clients' needs including certified Play Therapy, Nature Therapy, and Equine-assisted Therapy. Our therapists are skilled in addressing issues and providing counseling for areas such as premarital, crisis, postpartum, anxiety & depression, marital and infidelity issues, addictions, trauma, sexual addictions, and career counseling.

We exist because the churches of our communities are often unable, in financial or staff terms, to meet the needs of those experiencing psychological, emotional, family, and marital stress; specifically, most churches are unable to provide ongoing professional therapeutic help. We are striving to meet these needs in ways that support and assist the churches of our community and are, at the same time, both biblically and professionally responsible.

Why it is important to fund this now-

Restore Counseling Center receives an increasing number of requests for mental health services daily. The need for mental health attention and strategies is evident in Chester County and throughout Pennsylvania. Restore Counseling Center plans to expand services to meet the increased needs of both adults and children ages 4-17.

Since 2021, Gateway Church in Parkesburg has provided space in their church to support Restore Counseling Center's efforts to meet the mental health needs of the local community.

In 2025, Restore plans to transition from the complementary space in the church building to a rental house on the church property that will provide increased office space for counseling and group therapy, as well as for the expansion of the certified Play and Nature Therapy services for children.
