Mission:

Eastern PA Trans Equity Project's (EPTEP) Mission is to Empower Transgender People while Building Community. Working across 42 underserved rural, exurban, and suburban Pennsylvania counties including Chester County.

We provide meaningful Supportive Services, Advocacy, Assistance Programs, Empowerment Programs, and Educational Opportunities, that help transgender people to not only survive, but to thrive.

We serve over 6,000 people annually with programming that has a deep, positive, and affirming impact on the lives of transgender Pennsylvanians.

Our programming includes:

- Supportive Services: 21 Peer-led Community Groups, Info/Referral Line, Mentoring and Case Management to help people obtain the resources they need.
- Basic Needs Assistance: Rent, Food, Utilities, Transportation, and Medicines to help people maintain their ability to go to work or school
- Legal Name Change Assistance: To help people obtain legal ID and recognition of their chosen name under law
- Empowerment Programs: Workforce Development Education, Safety Training and Scholarships designed to help transgender people obtain the tools they need to thrive in the long term
- Education and Training: for Medical Providers, Social Service Agencies, Companies, and Government Agencies so they can provide culturally competent services to the transgender community.
- Advocacy & Action: Activating the LGBTQ+ community to work across all levels of government to ensure their rights are protected, legislative action, and work on behalf of individuals facing discrimination

Describe Population Served & Annual Number of People Served. (Include Chester County # &/or % served.)

Poverty and a lack of economic opportunity for transgender people are significant issues across Pennsylvania. These issues are further exacerbated in the suburban and rural areas of the state where there are fewer services available to transgender individuals. That is where EPTEP comes in.

- According to the 2022 Pennsylvania LGBTQ Health Needs Assessment, up to 50% of trans folk in our service area have experienced homelessness, up to 53% have food insecurity, and up to 46% live below either the poverty line or the ALICE (Asset limited, income constrained, employed) line. These numbers are almost double the national average for the transgender community.
- According to the 2022 National Trans Survey, transgender people are unemployed at a rate up to 5x
 the national average. When they are employed, they experience rates of harassment that are 3x the
 national average. The same study indicated that 48% of transgender patients have had negative
 experiences in healthcare settings and that 81% did not have all of their legal ID match their gender
 identity.
- A 2020 study from the Williams Institute indicates that transgender people are 4x as likely to be physically assaulted and FBI hate crime statistics indicate that 67% of all LGBTQ hate crimes are perpetrated against transgender women.
- A study from GLSEN indicates that transgender high school students are 34% less likely to pursue education beyond high school.

Because of these issues, members of the transgender community have a low level of trust in traditional service providers and social safety net agencies. EPTEP is the bridge that can provide them - not only with immediate assistance – but with the trusted referrals, connections, and case management that they need so they have the opportunity to lead productive and healthy lives.

We serve over 6,000 people annually. Through the first three quarters of 2025 we have provided services to 338 Chester county residents. We expect this number to increase significantly in 2026.

About Eastern PA Trans Equity Project (EPTEP)

Eastern PA Trans Equity Project's Mission is to Empower Transgender People while Building Community. Working across 42 underserved rural, exurban, and suburban Pennsylvania counties including Chester County. We provide meaningful Supportive Services, Advocacy, Assistance Programs, Empowerment Programs, and Educational Opportunities, that help transgender people to not only survive, but to thrive.

We serve over 6,000 people annually with programming that has a deep, positive, and affirming impact on the lives of transgender Pennsylvanians.

We are the only transgender-led organization providing our level of services in Chester County. We regularly receive referrals from Chester County based organizations including the LGBTQ Alliance of Chester County, West Chester University, United Way, PA 211, and more.

Supportive Services, Legal Name Change, and Empowerment Programs:

EPTEP's Supportive Services, Basic Needs, and Empowerment Programs help transgender individuals overcome many of the obstacles they face. Providing financial assistance, scholarships, mentoring, referrals and/or case management. They include:

- Housing and Rental Assistance: Housing insecurity is a significant issue for transgender people and we
 know that once a person becomes unhoused the likely hood for their achieving success decreases
 significantly. EPTEP will pay rent and/or a security deposit to a landlord on behalf of a transgender
 person/parent of a transgender child in need so that they can remain securely housed and focused on
 school and work.
- <u>Legal Name Change Assistance</u>: We provide mentoring and financial assistance with completing legal name changes and the procurement of legal ID that aligns with their gender so that they can apply for work and access services without being outed as a transgender person.
- <u>Basic Needs Assistance</u>: EPTEP distributes small grants or financial vouchers to transgender people and families of transgender children helping them to purchase household groceries, personal care items, clothing, address critical vehicle repairs, pay their utility bills, or afford transition-related prescription medication so that they can go to work or school.
- Workforce Development and Education Programs: Launched in 2024, EPTEP is partners with major
 employers to ensure transgender people have an opportunity to gain quality employment while learning
 the critical employment and life skills. Cohort members receive free skills training to help them secure
 employment, mentorship for a period of one year after employment, and retention bonuses to build
 resilience.
- <u>Scholarship Programs</u>: Educational and conference scholarships that are designed to help transgender people secure good jobs and connect with the legal and medical services they need to be successful.
- <u>Personal Protection Training</u>: Transgender people especially transgender women are subject to extreme levels of violent and assault. Each year we conduct personal safety workshops to teach them

how to avoid or navigate dangerous situation while distributing personal protection kits that include personal alarms, flashlights, whistles, and other items.

- <u>Peer Support Groups</u>: We provide peer support services through twenty-one (21) support groups that meet in-person, virtually and online. We are launching a new group in Chester County (Exton) effective December, 2025.
- <u>Infoline</u>: We provide access and referrals to trans-affirming services to gender-diverse people seeking resources.

Our Results:

Over the past four (4) years we have:

- Provided over \$570,000 in direct financial assistance to transgender people in need.
- Assisted 1,463 people with legal name changes.
- Kept 191 people in secure housing.
- Provided food assistance equivalent to over 7,500 meals.
- Supplied 327 people with gender-affirming clothing.
- Helped 243 individuals with utilities, medication, transportation and other basic needs.
- Awarded 36 people with college scholarships.
- Helped 41 people attend the Keystone Gender Diversity Conference at no cost.
- Served over 7,900 visitors to our peer-led support groups.
- Answered over 5,600 inquiries for services and referrals through our Infoline.

Program Evaluation

EPTEP's Supportive Services, Basic Needs Assistance, and Empowerment Programs are evaluated on a qualitative and quantitative basis.

We track all clients' demographic information including age, fender identity, county of residence and race. Additionally, we track the success rate of our clients based on program metrics such as successful completion of legal name changes or success at remaining housed/employed.

- Legal Name Change clients receive ongoing mentoring throughout the name and legal ID change process which includes initial training/mentoring and email or phone check-ins every 30 days.
- Rent Assistance clients receive ongoing follow-up at 30, 60, and 90 day intervals to ensure they remain housed and are connected to additional services.
- All clients are invited to participate in an annual blind survey where they can give frank feedback on our programming.
- We have a Community Advisory Board that meets twice-yearly to provide feedback and input on programming.
